By subscription of \$100 each to accompany the nomination or by supplementary nomination of \$2,000 by time of entry. \$1,000 additional to start, with \$100,000 added. The added money and all fees to be divided 60% to the winner, 20% to second, 12% to third, 6% to fourth and 2% to fifth. \*Early Bird nominees to the 2007 Santa Anita Derby (Closing Date: Thursday, December 14, 2006) are automatically eligible to the Sham Stakes with all fees waived. Weight: 122 lbs. . Non-winners of a sweepstakes at one mile or over, 2 lbs.; one race other than maiden or claiming at one mile or over, 4 lbs. Starters to be named through the entry box by the usual time of closing. A trophy will be presented to the owner of the winner. Closed with 150 early and 5 regular nominations.

RAVEL saved ground while tucked behind the leaders, swung three-wide into the stretch, collared LIQUIDITY in midstretch and inched clear under urging. LIQUIDITY dueled for the lead outside of SONG OF NAVARONE, gained a short advantage a into the second turn, continued to battle when engaged by the winner in the lane and yielded grudgingly. SONG OF NAVARONE dueled inside, maintained a short lead nearing the second turn, fought back when headed in the stretch and held on for the show. KOLO pressed the pace while three deep on the first turn, continued to track the leaders on the backstretch and gave way under pressure on the last turn. SILENT SOUL saved ground throughout and did not rally. PIRATES DEPUTY was three-wide on the first turn, raced within striking distance on the backstretch but had no response when asked. TIME SQUARED, off a step slow, was carried four-wide around the first turn, chased outside, dropped back and gave way.
