SASSY IMAGE angled out on the first turn and relaxed while within easy range of the leaders, picked up her pace four wide on the second turn, challenged approaching the stretch, raced DECELERATOR into defeat inside the final furlong and drew off late. DECELERATOR pressed the pace three wide, challenged on the second turn, went with the winner when that one ranged up on the outside approaching the stretch, maintained contact to the final furlong and while unable to keep up late, was clearly second best. UPPERTIME outrun early, made a solid four wide move late on the second turn but tired in the drive. VIVID COLORS set the pace off the inside, stayed on well to the stretch and tired. ALL DUE RESPECT close up along the inside, faded. CANADIAN STORM was no threat.
