All Entries become the exclusive property of Sponsor and will not be returned or acknowledged except as provided herein. In the event of a dispute as to who submitted an Entry, the name of the "authorized account holder" associated with the email account will

be deemed to be the entrant as long as such person is eligible and in compliance with these Official Rules. The authorized account holder of the email address is defined as the natural person who is assigned to the email address by an Internet access provider, online service provider, or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Approximate Retail Value ("ARV"): \$35,975. Actual value depends upon point of departure and other fluctuations. Winner must be available to travel from 9/3/20 - 9/6/20. If winner is unable to travel from 9/3/20 - 9/6/20 prize will be forfeited in its entirety and Sponsor will have no further obligation to the winner. Winner and guest are solely responsible for making their own travel arrangements to/from Louisville, KY.
