A Supplementary Nomination of \$15,000 each may be made at time of entry, \$7,500 to pass the entry box; \$7,500 additional to start, with \$1,500,000 guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to brind 54% to fifth. Weight: 121 lbs. The maximum number of starters for the Longines Kentucky Oaks will be limited to fourteen (14) with up to four (4) horses designated as also-eligible to start. If more than fourteen (14) entries pass the entry box, preference will be given to those horses that have accumulated the most points pursuant to the Road to the Kentucky Oaks as published by CDRT.
