Weight: 122 lbs. Non-winners of a graded sweepstakes on the turf allowed 2 lbs.; two races other than maiden, claiming or starter on the turf, 4 lbs. The maximum number of starters for the William Walker will be determined at the time of entry dependent on rail placement. In the event this race overfills preference will be given to graded stakes winners (in order I-II-III), then highest turf and synthetic earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner.
