\$150,000

FOR HORSES WHICH HAVE STARTED FOR A CLAIMING PRICE OF \$25,000 OR LESS IN 2023-24 Age: Three-Year-Olds & Up Distance: Five- and One-Half Furlongs (5.5 f) on the turf Purse: \$150,000 guaranteed plus \$20,000 KTDF. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Three-Year-Olds 124 lbs. Four-Year-Olds and Older 126 lbs. Fillies and Mares allowed 3 lbs. Non-winners of a stakes race in 2024, allowed 2 lbs.; of a stakes race in 2023 or two allowance, starter races for \$25,000 or greater, or claiming races of \$30,000 or greater since June 1, 2024, allowed 4 lbs.; non-winners of such a race since then, allowed 6 lbs. Preference given to graded stakes winners, then graded stakes placed, then stakes winners in 2023-24, then by highest earnings in 2023-24. Management reserves the right to transfer this race to the main track if it is considered inadvisable.
