FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD By subscription of \$1,00 each, which should accompany the nomination or by Supplementary Nomination of \$1,500 at time of entry, \$750 to pass the entry box; \$750 additional to start, with \$150,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight, 123 lbs. Non-winners of a grade I since October 1, allowed 3 lbs.; a graded sweepstakes since July 4 or \$62,500 twice since November 1, 5 lbs. The field will be limited to 14. If more than 14 entries pass the entry box preference will be given to graded stakes winners (in order I-II-III), then highest 2024-2025 earnings. Trophy to the winning owner.
