**FOR FILLIES, TWO YEARS OLD** By subscription of \$100 each or by supplementary nomination of \$3,000 each at time of entry. \$750 to pass the entry box; \$750 additional to start, with \$225,000 guaranteed plus an additional \$75,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. The winner of the 2025 Pocahontas (Grade III) at Churchill Downs will be granted an automatic berth (no fees) to the Golden Rod (Grade II) at Churchill Downs November 29, 2025. The Pocahontas has been selected as a Breeders' Cup Dirt Dozen Bonus Series Race for the \$2 million Breeders' Cup Juvenile Fillies on October 31, 2025 at Del Mar. The nominated winner of the Pocahontas will receive a credit of \$30,000 toward entry fees for the Breeders' Cup Juvenile Fillies, second place will receive a \$15,000 credit toward entry fees and third place will receive a \$7,500 credit toward entry fees. Weight: 122 lbs. The maximum number of starters for the Pocahontas will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), then highest non-restricted earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box by the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Certain finishing positions in this race will earn points to qualify for the 2026 Kentucky Oaks, pursuant to the official rules for the Road to the Kentucky Oaks published by Churchill Downs Incorporated. A trophy will be presented to the winning owner.
