Once a horse receives the initial EHV-1 vaccination, revaccination should occur every 120 days. Please note the minimum 14-day requirement applies only to horses that have not been vaccinated for EHV-1 during the preceding 120 days.

Horsemen-parking in the infield is allowed on race days but no cars or golf carts can go through the frontside tunnels during racing.
