**FOR FILLIES, THREE YEARS OLD** Nominations close Wednesday, September 3, 2025 with no nomination fee. A \$750 Supplementary nomination may be made at time of entry. \$500 to enter. \$110,000 guaranteed plus an additional \$65,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a Grade I or Grade II stakes at a mile or over, allowed 2 lbs.; a Grade III at a mile or over in 2025, 4 lbs. The maximum number of starters for the Seneca will be limited to fourteen (14). If more than fourteen pass the entry box preference will be given to graded stakes winners (in order I-II-III), then highest non-restricted earnings in 2025. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. A trophy will be presented to the winning owner.
