Vaccination Requirements: Each horse entering the backside must be vaccinated against Equine Herpes virus Type 1 (EHV-1) by or under supervision of a licensed veterinarian a minimum of 14 days and no more than 120 days prior to entering the stable area. The inoculation should be recorded on the CVI by the issuing veterinarian and include the name of the product administered and date of inoculation. Once a horse receives the initial EHV-1 vaccination, revaccination should occur every 120 days. Please note the minimum 14-day requirement applies only to horses that have not been vaccinated for EHV-1 during the preceding 120 days.

Trainers, please be aware when signing up for digital tattooing, payment MUST be made at time of tattoo.

TRPB DIGITAL TATTOO- 2025 Update Churchill Downs
Payment MUST be made at time of tattoo
Sign up for tattooing at the Churchill Downs racing office-list the horse's name, barn number, your name, and phone number. The TRPB Technician will scan the

microchip to access the digital copy of the foal certificate, validate the information, verify the markings, color and gender, then take 10 -14 photos of the horse to digitally document all equine attributes. Bandages, poultice, blankets must be removed, and the horse must be named by the time the TRPB Technician is present to certify its identity. The Digital Tattoo-fee is \$110 which MUST be paid prior to the TRPB Technician performing the work. Payment can be made by Credit Card, Apple Pay or Google Pay. If arrangements are made with the Churchill Downs bookkeeper's office to provide a bookkeeper's check made out to TRPB in the appropriate amount, this check must be turned over to the Technician at the time of certification. HORSEMEN PLEASE BE AWARE OF THE EQUINE SAFETY INITIATIVES ON PAGES 3 AND 4 OF THE CONDITION BOOK. Most importantly-ENTRY RESTRICTIONS: Trainer will not enter in any race a horse that is a four-year old or older first time starter or a previously-raced horse that has not raced in the 365 days preceding the date of the selected race UNLESS such horse has completed an official work for the KHRC veterinarian or his/her designee prior to entry. Any horse that has previously raced, but has not raced in the past 150 days must submit a Layoff Report in the HISA portal PRIOR to entering the horse in a race. Horses that have not raced within the past 30 months are ineligible to train or race at any Churchill Downs property, unless approved in advance by the CDI Equine Medical Director.

Horsemen-parking in the infield is allowed on race days but no cars or golf carts can go through the frontside tunnels during racing.

ATTENTION HORSEMEN: Please have your racing license and proper parking tags available for security when coming to the races and barn area.

By Order Of The Stewards, if your horse is claimed you will have 72 hours to produce the foal certificate to the new owner. Contact the Identifiers Office at (502) 638-3826 to help coordinate transfer. Additionally, a bill of sale will be required for all changes of ownership.

ATTENTION HORSEMEN: The stewards shall not void the claim if, prior to the race in which the horse is claimed, the claimant indicates on the claim blank that he or she elects to claim the horse regardless of whether or not the commission veterinarian determines the horse will be placed on the Veterinarian's List as bled, unsound or lame.

ATTENTION HORSEMEN: All Schooling vests should be left at the end of the tunnel in the vest bin.
